BACKGROUND:

The Municipal Act, Sec. 284 requires the Director of Finance to file with Council by the 31st of March, a statement of total remuneration and expenses paid in the previous year to members of Council in respect of his or her services as a member of Council or any other body, including a local board. Further, the Treasurer is required to include each person appointed by the municipality to serve as a member of any body, including local boards. Salary, expenses and benefits for Mayor and Council are paid in accordance with Council Resolutions dated July 17, 2006 and September 18, 2006 respectively.




