Step 3: Support Materials

The following support materials will provide information and details to aid the City's councilappointed Public Art Advisory Committee and the inter-departmental Public Art planning team in the decision making process.

Donations will be evaluated using the following criteria:

- Suitability of work in complementing and avoiding duplication in the City's collection
- Artistic merit and condition of artwork
- Appropriateness of subject matter and site availability/suitability/compatibility
- Financial implications and technical installation requirements
- Durability and maintenance requirements, susceptibility of work to degradation, wear or vandalism, and public safety
- Documented evidence that the work has been legally and ethically acquired with the absence of conditions

1. **Description of Proposed Donation** (not to exceed 2 typed pages) **including:**

- a. Background/History of artwork and artist
- b. Rationale for donation and significance of artwork to City of Guelph
- c. Site preparation/installation requirements
- d. Current condition of artwork

2. Project Budget

The acquisition of gifts, donations and bequests of artworks requires the City of Guelph to designate funds toward the installation and maintenance of these pieces. All expenses related to the donation and review process rest with the donor.

- a. Estimated cost associated with the installation of artwork
- b. Estimated cost of ongoing maintenance, insurance and other long-term issues

3. Artwork Documentation

Please include photographs (or drawings/maquettes if applicable) of the artwork and a copy of the current professionally approved appraisal^{iv} (for existing works of art only).

4. Additional Information for donations of work not yet created

- Description of the process used to select the artist/artwork, including a Call for Artists if selection has been/will be through competition
- Brief statement from the artist(s) about the proposed artwork and theme
- Project timeline
- Artist resume and any additional supporting material, including information pertaining to the artist's copyright and moral rights to the work
- Detailed budget including all projected costs for the project, funds committed to date and proposed source(s) of funds

If a tax receipt is requested, an appraisal of the artistic work, to determine its fair market value, will be required at the donor's expense.
