The Director of Environmental Services, Co-Chair of the Community Consortium briefly advised that the purpose of the Community Energy Plan was to establish community planning for the next twenty-five years. She introduced the members of the members of the Community Consortium who worked on the plan.

Mr. Art Stockman, Co-Chair of the Community Consortium introduced Peter Garforth of Garforth International, the consultant for the Community Energy Plan.

Peter Garforth of Garforth International highlighted the plan and advised that the goals of the Community Energy Plan are:

- Guelph will be the place to invest, supported by its commitment to a sustainable energy future;
- Guelph will have a variety of reliable, competitive energy, water and transport services available to all;
- Guelph energy use per capita and resulting greenhouse gas emissions will be less than the current global average;
- Guelph will use less energy and water per capita than comparable Canadian cities;
- All publicly funded investments will visibly contribute to meeting the other four CEP goals.

He further advised that the prioritized strategies for 2007 - 2031 relate to high construction efficiency standards; transportation efficiencies; heat recovery; renewable solar; restructured energy services supply company; and selected "scale projects".

He suggested that the initial scale projects include St. Patrick's Ward and the downtown, University of Guelph and the south end of the City.
