DELEGATIONS

Loretto Convent

Katherine McCracken, Director of Guelph Museums was present and briefly reviewed the events to date with respect to the Museum's relocation or expansion. She advised that the feasibility study shows the Loretto Convent would be a good fit for museum use and that this potential site is available now with a long term lease opportunity at a nominal cost. She further advised that up to one-third of the costs could be funded by a grant from Cultural Spaces Canada, but that the project must be substantially completed by 2010, with a lease in place by October of this year. She also advised that the Diocese of Hamilton has informed the City that they would only be receptive to a museum use for this site and if the proposed expansion by the Museum is not approved then they will be proceed with the demolition of the structure.

Ian Brown, Chair of the Museum Expansion Sub Committee expressed concern that if the project is not moved forward then the City would lose the opportunity of receiving up to one-third funding of the project from the federal government. He advised that the feasibility study shows that the site meets the museums requirements, and that the structure is in a good location and in a historical building.

Dr. Gil Stelter advised that the civic museum plays an important heritage role in the City. He suggested that moving the Civic Museum would enhance the City's cultural education and development.

Paul Ross, Chair of Heritage Guelph, advised that Heritage Guelph has been consistently opposed to the demolition of the Loretto Convent. He advised that they are supportive of the convent becoming the new home for the Guelph Civic Museum. He suggested that moving the museum to this location would help to revitalize the downtown. He also advised that the future of the Loretto Convent is being closely watched by the broader heritage community in the province.

Clover Woods suggested that obtaining the Loretto Convent would be an investment for the City. She further suggested that the structure would be a perfect fit for the museum and that the time is right. She urged Council to maintain the building as part of the Macdonell family heritage.

Timothy MacDonell was present and advised that family members assisted in the construction of some of the historical buildings in the City. He also advised that various of his neighbours are in support of maintaining the building and moving the museum to that location. He requested that Council relocate the museum to the Loretto Convent and move the project forward in the capital budget. He also suggested that the structure must be designated historically significant.

Brian Holstein urged Council to seize the opportunity to expand the Guelph Civic Museum and to protect the Loretto Convent structure. He suggested that grants from the federal government will not always be available and that the City should take advantage of the present grant funding.

Dorena Griffin advised that the opportunity is favourable to relocate the Museum, as there is substantial federal grant funding available. She also suggested that the feasibility studies have proven that this location would be ideal for a museum.
