#### RECOMMENDATION

That the information report of the Director of Information Services/City Clerk regarding the Business Licence By-law Review Process dated April 14, 2009 be received.

# **BACKGROUND**

In 2004 Council passed the current business licensing bylaw (2004)-17551 On January 1, 2007, Bill 130, the Municipal Statute Law Amendment Act, came into force and effect substantially changing the provisions pertaining to business licensing.

The amended act gave municipalities broader licensing and enforcement powers. Specifically, municipalities were no longer limited regarding the reasons for licensing which were as follows:

- health & safety,
- consumer protection
- nuisance control.

As a result, Council approved a recommendation On October 15, 2007 to reflect that the purpose for licensing businesses is primarily for the health, safety and well-being of the public, where there is a municipal interest that is not otherwise legislated. Examples of businesses meeting these purposes are establishments where food is prepared or sold, or where large assemblies are inherent in the business. These are cases where there is a greater interest in health, sanitation, and safety where a higher degree of inspections is warranted.

Staff initiated a review of the business license bylaw, accordingly, to conform to the new reasons for licensing. Concurrently, a service review was conducted which resulted in a consolidation of bylaw enforcement including the enforcement of the business licensing bylaw.

#### **REPORT**

A review of the legislation and other municipalities' documents was conducted, among them, Barrie, Burlington, Cambridge, Kitchener, Kingston, Waterloo. Projections of actual costs for fire, building, zoning, Public Health inspections and administration including enforcement were calculated. A staff working group and sub groups comprised of representatives from City Clerks, Building, Zoning, Court Services, Fire Services, Legal services, Guelph Wellington Dufferin Public Health met on several occasions. There was also consultation with Guelph Police Services.

Based on the criteria established by Council, staff will be proposing that the following business categories continue to be licensed:

Adult entertainment (to include establishment and retail)

Amusement establishment

Bed and breakfast

Catering company

Food premises to include restaurant and any other premise or vehicle where food prepared or packaged is sold

Holistic services/ operator/practitioner (not to include mind control)

Hotel establishments

Pawnbroker

Personal service establishment (to include hair salon)

Private parking agent

Public Hall (to include halls, theatres & indoor flea markets exceeding 100 people) Street vendor (City tendered vendor on City Property)

The business categories retained are consistent with the new purposes for licensing being the health, safety and well-being of the public where there is a municipal interest.

Staff will be recommending that 14 categories be removed. 5 categories have been incorporated into the remaining business to be licensed. 18 categories will continue to be licensed.

Many of these licences are proposed to be discontinued because they are regulated or governed by another level of government or agency. An example is the tobacco licence which predated the Smoke Free Ontario Act. The province now has the authority under this legislation to regulate tobacco sales. With regard to pet stores, the *Ontario SPCA Act* mandates the Society to enforce animal cruelty laws and provides Ontario SPCA Community investigators with police powers to do so. Retail establishments, Auctioneer and Door to door sales are being removed as the city has removed Consumer protection as a reason for licensing.

Please note that all business, regardless of whether they are licensed or not, are still subject to the requirements of the Building Code, the Fire code and the zoning By-law.

The categories proposed to be discontinued are as follows:

Auctioneer
Billiards Establishment
Bowling Alley
Door to door sales
Driving Instructor/ school
Laundromat/drycleaner
Pet shop
Physical fitness centre
Plumbing contactor
Backflow device Tester
Drain contactor
Retail business
Tobacco
Vehicle service establishment

Staff will be developing a distinct process for inspections related to business licensing and the application for the licence. The cost for such is proposed to be based on actual costs of inspection and processing the application. Therefore a new schedule of fees will be proposed.

The following consultation plan and Committee/Council schedule is being proposed to seek input from the public and groups representing businesses in the City of Guelph:

June 22: Report regarding new business license bylaw to Council for approval

Sept. 28: Passing of Bylaw as directed by Council in June

After Sept 28:Ad in paper regarding new Business licensing bylaw

Jan. 2/10: New licensing Bylaw in effect
