Integrated Operational Review (IOR) - Annual Report

(2015 - 2016)

Staff Report 16-53 recommends that Council enact a new Site Plan Control Bylaw (for reasons outlined in the report) and the new by-law is included as Attachment 2 to the Report.

Staff views the need to replace the City's current 1995 Site Plan Control By-law with an updated and modernized by-law as largely an administrative, technical matter. However, due to recent input from a number of members of the IOR Business Stakeholder Working Group, it is evident that additional time is needed to consult with Business Stakeholders regarding the proposed Site Plan Control By-law update.

Staff are therefore recommending that Council **NOT** consider enactment of the proposed Site Plan Control By-law at this time. The text in the main body of Report 16-53 dealing with the by-law can remain as-is, since it provides useful context, however it is recommended that the report Recommendations be revised to delete Recommendation 2 dealing with enactment of the By-law, and that Attachment 2, being the proposed By-law, instead be used as a basis for further consultation with Business Stakeholders. Attached to this memo is a revised set of Report Recommendations reflecting this change.

Staff will report back to Council on this matter at an appropriate point in the future once discussions with the Business Stakeholders have been concluded.
