### Presentation

#### **Transit Growth Strategy Implementation**

The Mayor arrived at the meeting.

Mr. Michael Anders, General Manager, provided an overview of changes made to the transit routes since their implementation in January. He advised of next steps, system performance issues and other risks within the system. He also stated that vehicle acquisition is a priority to meet capacity issues.

Mr. Rodney Kellar, General Manager, Public Works, advised that were four used buses have been purchased and should be fully operational within two to four weeks. He stated capital budget from surpluses from last year are being used to purchase the buses. In addition, two

new buses which are included in the capital budget are also being purchased.

Mr. Kevin Chernoff, a City resident, advised that his travel time to and from work has doubled since the implementation of the new transit routes. He stated that he is rarely able to catch his transfer bus . He requested that further consideration be given to the transfer issues and suggested that shelters should be put in place at the transfer points.

Staff will address performance and design standards, input from the public and provide performance measures when they provide their transit report in the second quarter of 2012. They advised comparisons of some items such as overall ridership; overall system measures, and schedule adherence will be provided.

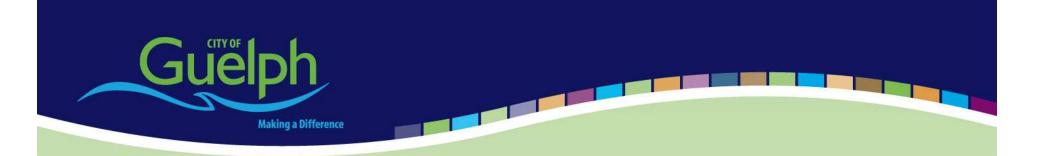

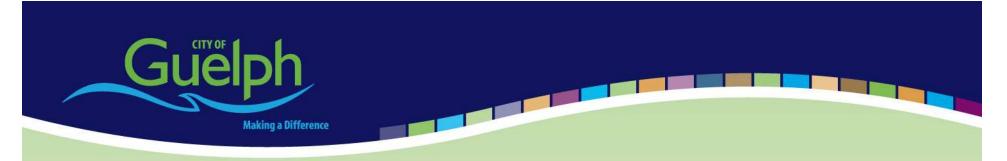

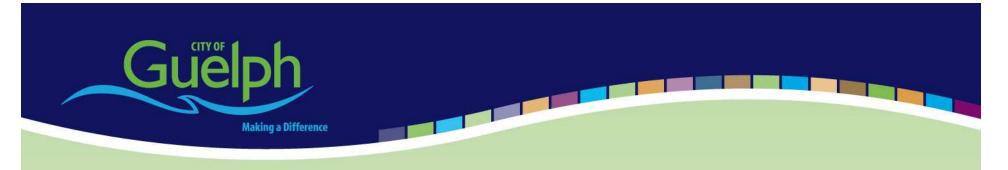

## **Guelph Wellington Emergency Medical Service (GW EMS)**

- Guelph and Wellington County
- Area covered is in excess of 2600 square kilometres serving a resident population of over 200,000.





## 2011 Call Volumes

33,567 ambulance calls (emergency & non-emergency) in Guelph and Wellington County

16,539 of those were patient related serious emergency calls

Compares with 15,779 from 2010 15,426 from 2009



## Provincial Dispatch - Seamless Service

- Central Ambulance Communication Centre – 100% funded & operated by Province of Ontario
- Ambulances serve local coverage areas
- Provincial system of emergency medical responders
  - May be required to respond anywhere as directed by the Province

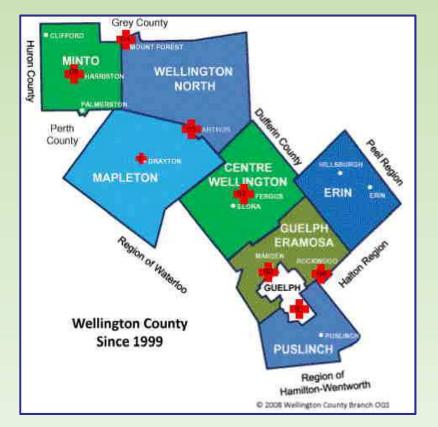


Provincial - Central Ambulance Communications Centre - CACC



## Local Ambulance Deployment

- Ambulances are stationed and deployed based on geography, historical call volume and population expectations. Historical station locations and municipal boundaries are also a factors.
- Ambulance are positioned for optimal response closest to where the emergencies can be expected to occur to provide the an effective response time with available resources.

# Ministry of Health Service Review

- Required as part of certification to operate service
- Past service reviews included October 2008 (pre assumption) and April 2009
- in 2009, found to have substantively met the requirements of the Land Ambulance Certifications Standards.
- Next review scheduled for April, 2012.
- Failure to meet the service review standards could eventually lead to decertification.

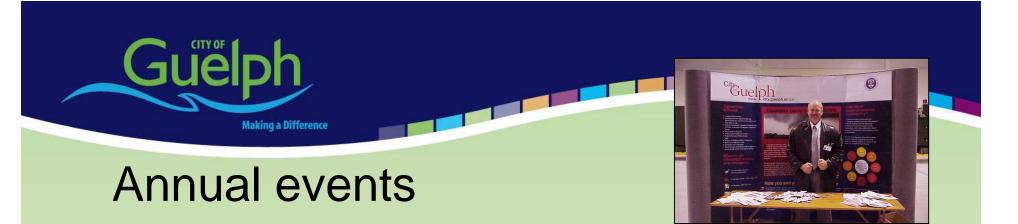


# Emergency Services Emergency Preparedness and Management





- Guelph has had an emergency plan for at least 4 decades. It wasn't mandatory until 2003.
- Guelph has two properly equipped Emergency Operation Centres.
- EOC's have electronic logging system, GIS mapping with multiple layers and plume modelling available to EOCG and incident managers.
- CEMC & 2 alternates have a total of 87 years experience. The CEMC's are on call 24/7/365.
- We have three Duty Officers who are on call 24/7/365.
- The Emergency Operations Control Group is also on call 24/7/365.



- Training is intensive and ongoing. It includes:
  - Annual emergency management exercise for EOCG and support personnel
  - Two exercises for Incident Managers (core group of Fire & Police)
  - Live 'boots on the ground' evacuation exercises
  - Minimum of two Basic Emergency Management courses per year
  - Scribe training seminar
  - Public Education including website with downloadable information, children's activities, info for persons with disabilities. Annual EP day.

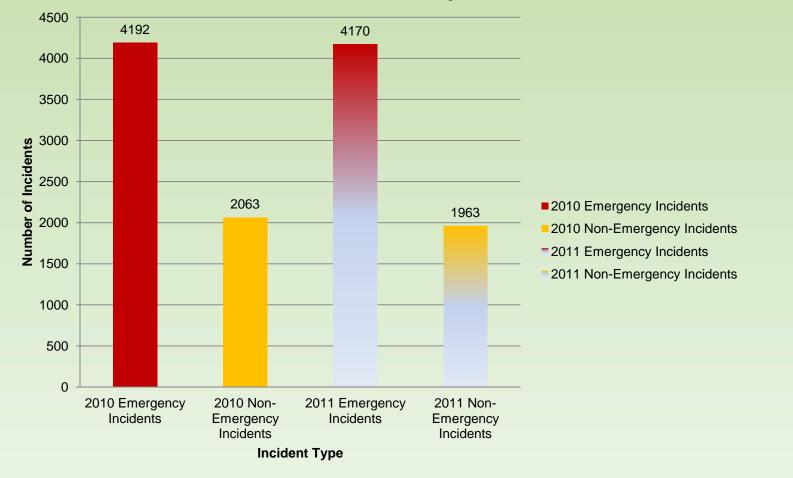

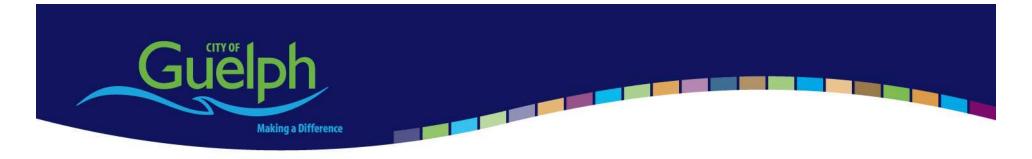

## SUBJECT U-Pass Contract Renewal

### SUMMARY

#### **Purpose of Report:**

To provide a summary of the recommended changes to the U-Pass pricing structure for the Spring and Fall semesters in 2012 and the Winter semester in 2013.

#### **Committee Action:**

Recommend to Council the execution of a one year U-Pass Agreement between the Corporation of the City of Guelph and the University of Guelph Central Student Association (CSA) and the City of Guelph and the Graduate Students' Association (GSA).

### RECOMMENDATION

THAT the Operations & Transit Committee Report OT031206 U-Pass Contract Renewal dated March 19, 2012 be received;

AND THAT the Mayor and City Clerk be authorized to sign the U-Pass Agreement with the University of Guelph satisfactory to the Executive Director of Operations, Transit & Emergency Services and the City Solicitor.

## BACKGROUND

The City (Guelph Transit) has had a U-Pass Agreement in effect with the University of Guelph since the 1990's to provide unlimited bus service to University undergraduate and graduate students for a set fee per student per semester. University of Guelph students are not eligible to opt out of the program and must pay this fee to the City each semester regardless of whether or not they use the services of Guelph Transit. A separate agreement is in place with the Central Student Association (CSA) and the Graduate Students' Association (GSA).

The previous agreements were signed in 2010 covering the period from May 2010 through the end of April 2012. New agreements with revised pricing need to be approved to be effective starting May 2012.

## REPORT

Although the parties to this agreement (Guelph Transit, CSA and GSA) prefer multi-year agreements, the time and resource limitations resulting from the implementation of the Transit Growth Strategy at the beginning of 2012 precluded staff from negotiating one. Multi-year agreements are more complex and often require a referendum for the students to be staged so they may vote in true democratic fashion. Any proposed increase above 5% automatically requires a referendum to be staged. The parties recommended one year agreement contains a reasonable price increase (less than 5%) that does not require a referendum vote.

It is recommended the following pricing structure per student per semester for both the CSA and GSA agreements be approved:

Spring 2012: \$86.00 (same as existing price) Fall 2012: \$89.50 Winter 2013: \$89.50

The proposed increase for the U-Pass (4.1%) for Fall 2012 is in-line with the general fare increase that Guelph Transit will be putting into effect September 2012 (4.3%).

All other terms and conditions in the existing agreements will remain in effect until comprehensive negotiations start in Fall 2012 for new agreements to come into effect for the Spring Semester 2013. It is intended that multi-year contracts be signed at that point in time.

## FINANCIAL IMPLICATIONS

Based on the projected enrollment for Fall 2012, the proposed U-Pass price increase will generate the incremental revenue estimate included in the 2012 Guelph Transit Operating Budget.
