Norah Chaloner, for Council of Canadians- Guelph expressed the following concerns:

- Connect with idea of a Heritage River
- The Speed River and Eramosa River are Heritage Tributaries
- Invited an RSAC representative to sit on the Heritage Working Group for the Grand River
- Advised she will forward information to RSAC with respects to Heritage Rivers

Delegation:

Laura Murr, expressed the following concerns:

- Need to protect the Speed River and green spaces
- Does not support the skateboard park in this location
- Why put an expensive park in an area that will flood?
- No parking has been provided. There will be future parking needs
- The Park should be located in an area with lighting at night
- Bikes will hurt the naturalization
- City if the developer and regulator

Delegation:

Judy Martin, Sierra Club expressed the following concerns:

- Does not support the skateboard park in this location
- Referenced the 1993 Parks Naturalization Plan and the Parks Master Plan and noted that the proposed skateboard park is at odds with the above documents. She asked that the goals and objectives be re-evaluated against the above City Plans.
- The proposal doesn't complement the current use of the park
- The EIS should have been done before approval of the concept

General discussion took place and RSAC noted the following concerns:

- RSAC Procedural Protocol needs to be addressed
- Parking and intensification of the lands
- Concerns of site selection.
