Stephen Robinson, Senior Heritage Planner with the City of Guelph provided a PowerPoint presentation on the Draft Heritage Conservation District Plan and Guidelines and asked RSAC to provide any comments.

General discussion took place and Stephen Robinson was available to respond to questions from RSAC.

Mariette Pushkar noted the following in regards to water levels and flows:

• The HCD Study speaks to water level but not water "area". She noted that if you wanted to naturalize to benefit habitat or water quality, you could potentially maintain the water <u>level</u>, but for a smaller area.

Nicola Lower requested clarification of what is meant by "historic levels of water".

The floor was opened to delegations.

Delegation:

Hugh Whiteley gave a brief Power Point presentation on the "Boundaries of Heritage Landscape Districts" and noted the following:

- The importance of having boundaries with further setbacks from the river.
- Noted a naturalization plan for south bank of Royal City Park
 - o Issues:
 - Note that the boundary follows the edge of the river on the east of Gordon
 - It would be good to include the minimum buffers of OPA 42
 - Should consider generous boundaries to the river

Hugh Whiteley also spoke to the Wellington Street Dam and noted the following:

- Encourages the City to accept ownership of the Dam
- Decision is 5 years past due
- The community that grows up along the water's edge will have interest in keeping it.

Hugh Whitely recommended to revise heritage district boundaries based on landscape and a review of Wellington Street Dam ownership decision be made by Council.

General discussion took place and RSAC will continue to dialogue outside of this meeting. Comments were requested to be provided to Jeremy Shute by June 30, 2014. RSAC comments due to Stephen Robinson by July 3, 2014.
