

The Royal Flush rebate program is changing. Get a \$75 rebate on the replacement of a 13L or 20L toilet with a qualifying 6L dual flush model or 4.8L model until December 31, 2016. You have until March 31, 2017 to apply for the \$75 rebate. Toilets purchased after December 31, 2016 may qualify for the new rebate. Saving water and money is as easy as replacing your high water use toilets (13-litre or more) with new high-efficiency WaterSense® certified models through the City of Guelph Royal Flush Toilet Rebate Program.

Replace the high water use toilets in your multi-family residence (apartment building, housing condominium or townhouse complex) by December 31, 2016 and receive a **\$75 rebate** from the City of Guelph on your hydro bill for each approved high-efficiency toilet.

### **To qualify for a rebate:**

1. Contact Royal Flush Toilet Rebate Program staff at 519-822-1260 x 2633 to advise of the number of toilet retrofits to be completed and to learn about site inspection requirements.
2. Purchase and install new water-efficient toilets from the list of WaterSense® certified models to replace your existing high water use toilets (13-litre or more) by December 31, 2016. Visit [guelph.ca/royalflush](http://guelph.ca/royalflush) to view the list of WaterSense® certified models.
3. Review the Royal Flush Toilet Rebate Program Terms and Conditions (listed below) prior to completing your application.

### **Terms and conditions**

In consideration of receiving the rebate under this Royal Flush Toilet Rebate Program, the undersigned Applicant acknowledges and agrees:

1. THAT the Corporation of the City of Guelph (City of Guelph) is not responsible for the selection, installation or operation of the toilet;
2. THAT the toilet must be a new, water-efficient model from the Guelph-approved WaterSense® certified list and must be installed in a residence built prior to 1996, located in the City of Guelph and connected to the municipal water supply;
3. THAT the Applicant shall provide the City of Guelph or its agent with reasonable access to the toilet, that the City of Guelph or its agent may inspect any residence participating in this Program in order to verify the installation of the toilet and eligibility of the same, if the City of Guelph so requests, and that the City of Guelph or its agent may access utility billing account information for the purpose of monitoring water. **Be available for an inspection. The City of Guelph reserves the right to withhold the rebate based upon inspection results;**
4. THAT the City of Guelph does not guarantee or warrant the toilet or its installation, the performance, freedom from defects, quality of workmanship or suitability of the toilet or any installation thereof for any purpose, or the suitability of the premises for installation. Further, the Applicant acknowledges and agrees to assume any and all costs of the installation or any alterations necessary for the proper installation of the toilet;
5. TO indemnify, save and hold harmless the City of Guelph, and its agents, officials, officers, councillors and employees (collectively, the agents) against all liability, loss, costs, damages, and expenses, causes of action, actions, claims, demands, lawsuits and other proceedings, by whomever made, sustained, brought or prosecuted, including by third parties, involving bodily injury, death, and property damage, in any way based upon, occasioned by or attributable to the Applicant's participation in this Program; and
6. TO refund such rebate to the City of Guelph on request, if this application contains any material misstatement or misrepresentation on such Applicant's behalf, or if the Applicant breaches any of these terms or conditions.

### **Notice of Collection**

The personal information on this form is collected pursuant to the Municipal Act, 2001 and in accordance with the Municipal Freedom of Information and Protection of Privacy Act. This information will be used for the purposes of administration of the Rainwater Harvesting System Rebate Programs.
