

## INDUSTRIAL, COMMERCIAL AND INSTITUTIONAL (ICI) REBATE PROGRAM

Get a \$100 rebate for replacing an old, top-loading washing machine with a new ENERGY STAR®-qualified washing machine for a limited time. New washing machines must be purchased on or before December 31, 2016 to qualify. You have until March 31, 2017 to apply for the rebate.

### Save 35-50% more water using a high efficiency ENERGY STAR<sup>®</sup> washing machine.

Older, top-loading washing machine models may use much higher volumes of water and up to 50% more energy which leads to increased water use, and higher utility costs.

Saving money and water is as easy as replacing your old top-loading washing machine with a new HE front-loading ENERGY STAR<sup>®</sup> model through the City of Guelph Smart Wash Rebate Program.

Replace the high water use top-loading washing machines at your business, place of worship, nursing home, school or office place, and receive a \$200 rebate from the City of Guelph on your hydro bill for each approved high efficiency (HE) ENERGY STAR® washing machine.

### To qualify for a rebate

- 1. Contact Smart Wash program staff, at 519-822-1260 x 2633, to advise of the number of washing machine retrofits to be completed and to find out about site inspection requirements.
- 2. Purchase and install new HE ENERGY STAR<sup>®</sup> washing machines from the list of efficient models to replace your existing top-loading washing machines. Visit guelph.ca/smartwash to view a list of approved water efficient models.
- 3. Please review the Smart Wash ICI Rebate Program Terms and Conditions (listed below) before completing your application.
- 4. Complete your rebate application package in full and include:
  - Original receipt showing the washing machine has been paid for in full by December 31, 2016 (photocopies will not be accepted)
  - Completed ICI Rebate Application Form
- Mail your rebate application package by March 31, 2017 to: Smart Wash ICI Rebate Program

- 6. Be available for a site inspection.
- 7. Enjoy your water savings! Once your application has been approved the rebate amount will be credited to your hydro bill within 10 to 12 weeks.

### **Terms and Conditions**

Please note: Rebates are only available to Guelph Industrial, Commercial and Institutional facilities (including, but not limited to, businesses, churches, industries and educational institutions) that are connected to the municipal water system. To qualify, ICI applicants must also purchase a HE ENERGY STAR<sup>®</sup> washing machine from the list of City approved models. For a complete list of approved water efficient models please visit **guelph.ca/smartwash**.

In consideration of receiving a rebate in this Program, I release the Corporation of the City of Guelph, and its agents and employees ("the City") from all claims and actions, however caused, arising from my participation in this Program. I acknowledge that the City is not responsible for the selection, operation or installation of any washing machine replacement under this Program. I agree to allow the City access to water billing account information for the sole purpose of monitoring water savings and consumption. The City reserves the right to alter or cancel the Program at any time.
