#### **RECOMMENDATIONS:**

1. That City Council, as the Shareholder of Guelph Municipal Holdings Inc. ("GMHI"), direct the Chief Executive Officer and Chair of the Board of GMHI to pass a resolution of the GMHI Board, pursuant to which the Council representatives will be removed from the GHESI Board of Directors on a temporary basis, pending City Council's final decision on any proposed merger, approval of the governance structure of the merged entity, and the final restructuring of GMHI.

#### **REPORT:**

The City Council representatives on the Guelph Hydro Energy Systems Inc. ("Guelph Hydro") Board of Directors were reappointed pursuant to a resolution passed by GMHI, as Shareholder of GHESI (Attachment 1 to this Report), during the June 28, 2017 GMHI Annual General Meeting with GHESI.

Where any proposed merger discussions are concerned, the City Council representatives on the Guelph Hydro Board of Directors will be called upon to make decisions as both Directors of Guelph Hydro and as representatives of the City, *i.e.*, the Shareholder. This has the potential to lead to inconsistent decision making on the part of those City Council representatives, however inadvertent. Accordingly, it is hereby recommended that those representatives be removed from the Guelph Hydro Board, by way of resolution of the GMHI Board, pending Council's final decision on any proposed merger, approval of the governance structure of the merged entity, and the final restructuring of GMHI.

According to section 4.02 of the City and GMHI Shareholder Declaration regarding GHESI (the "Shareholder Declaration"), the Guelph Hydro Board shall consist of a minimum of five (5) members. Currently, the Guelph Hydro Board is composed of



eight (8) members, including five (5) independent Directors and three (3) City of Guelph representatives.

Section 4.03 of the Shareholder Declaration provides that GMHI, with the approval of the City, shall determine the composition of the Guelph Hydro Board.

Paragraph 4.06(b) of the Shareholder Declaration provides as follows:

"The City, through GMHI, may at any time by resolution of the City and the GMHI Board in its discretion terminate the appointment of a Guelph Hydro Board member prior to the end of the member's term and appoint a replacement member."

Pursuant to her August 18, 2017 correspondence to the Chief Executive Officer and Chair of the Board of GMHI, the Chair of the GHESI Board of Directors has advised that, if the Shareholder decides to remove the Council representatives from the GHESI Board of Directors, that decision will be accepted and the workings of the GHESI Board and its committees will continue.
