



The requested variances from the Sign By-law are recommended for approval for the following reasons:

- The requested sizes are reasonable given that use of the property permits commercial uses and the size of the signs would comply in a commercial zone (variances would be required for locations);

- The location of the proposed signs will not detract from the appearance of the building; and

Will the Public have Meaningful Input on First Comprehensive Review of City Council in Decades?

The City of Guelph will soon be embarking on the first comprehensive review of City Council in decades. At the July 2nd 2019 Committee of the Whole, Council approved the staff proposed motion to conduct a "Council Composition and Employment Status Review" (CCESR). This review (which was originally proposed in Dec 2013) will be conducted during the current council (2018-2022) with the intent that any proposed changes will be in place for the Fall 2022 election of the next City Council. The explicit questions that the review will address are:

- Do we have the appropriate number of Councillors?
- Should Councillors be elected by ward or city-wide? Or a mix of both?
- If we keep wards, where should the boundaries be drawn?
- Should Councillors remain part-time or become full-time positions? Or a mix of both?
- What is the appropriate amount and type of compensation for Councillors?
- What supports (staff, budget, etc.) are appropriate for Councillors?

This review is good news as it is long overdue! Guelph has changed drastically in the past 30 years and continues to change today. The population alone has ballooned from approximately 88,000 to 135,000 and is expected to reach 175,000 by 2031. This growth has not been equally distributed amongst the wards. While each ward has two councillors, some of these wards have nearly double the population of other wards. Since each councillor only gets one vote they should represent approximately the same number of residents but currently they do not. The services residents expect from the City have also changed drastically yet Council has remained unchanged.

It may be tempting to focus on compensation as it is easiest to discuss in concrete terms (and it is important) but I would argue the other questions are just as (if not more) significant in terms of their long term impact. This is a massive opportunity for the public to determine what they want Council to be like. The outcome of this review will significantly impact:

- Who runs for Council
- Who gets elected to Council
- How accessible, representative and accountable councillors are to residents
- Literally every decision Council makes in the future

City Staff have proposed that the compensation questions be addressed by a Citizen's Committee provided with expert advice as in the past, whereas the remaining questions will be addressed by a third party subject matter expert (aka external consultant) who will be required to engage the public via "Open House

Workshops" among other undefined methods. These are the "business as usual" approaches to Community Engagement for the City. I would strongly suggest that the "business as usual" approach is insufficient and inappropriate for a review of this magnitude and significance. This is not a typical major city endeavour like a new community centre. The outcome of this review will literally impact EVERYTHING the city does for the next 30+ years: taxes, budgets, community centres, etc. The public needs to have full confidence in the process in order to have any confidence in the outcome and therefore the legitimacy of future Councils. The best way to achieve that is to intimately involve the public in the decision itself. Ideally the public should feel they made the decisions and are imposing them on Council as opposed to the other way around. Even the City's own Community Engagement Framework would seem to demand a higher standard.

I implore City Council to follow its own stated principles and goals of Community Engagement and insist on the highest practical level of public participation. I would recommend something similar to a Citizen's Assembly/Reference Panel. "Business as usual" is not good enough for the first comprehensive review of City Council in 30+ years.

123 Guelph asks that when the Council Composition and Employment Status Review (CCESR) comes to Council on July 22nd, Council please direct staff to explicitly include consideration of Ranked Ballots as a component of the review. Ideally as part of the proposed Phase 1: Governance Review and Environmental Scan.

Consideration of Ranked Ballots should involve public consultations and since public consultations will take place as part of the CCESR: Phase 1 anyway on <u>VERY</u> relevant and inextricably related issues this is the perfect opportunity to avoid unnecessary duplication of the City's efforts.

While 123 Guelph has a strong preference for considering Ranked Ballots concurrently with the issues contained in the proposed CCESR Phase 1: Governance Review and Environmental Scan, ANY consideration of Ranked Ballots is preferable to NO consideration.

If Council and Staff are unwilling and/or unable to include Ranked Ballots concurrently with Phase 1 of the proposed CCESR despite the urging of 123 Guelph, please add Ranked Ballots as a 4th Phase or in any other form that you find acceptable.

I am concerned that the form of citizen consultation currently proposed will be inadequate.

City staff have proposed the questions around the composition of council will be addressed by an external consultant who will be required to engage the public via "open house workshops," among other undefined methods.

The danger here is that consultants will miss values that are important to citizens. Values that will not be addressed in the public engagement phase, because they had not been identified in the earlier 3rd party consultant's research.

A better workflow would be to engage the public FIRST, to draw out the values that are important. Only when fundamental values have been identified first can we ensure that those values are incorporated and balanced in a final recommendation. We would not be missing out on the expertise that outside consultants could provide, because those experts could be called by the assembly itself.

Citizen's assemblies have been used in Canada before, notably the Citizens' Assemblies on Electoral Reform in British Columbia and Ontario. There work of these assemblies were well received by the public, and have been used as models elsewhere in the world.

Council should consider implementing some form of citizens' assembly or reference panel for the very important work of redesigning our electoral system in Guelph.
