Mr. Derrick Thomson, CAO, provided introductions to the Complex Capital Projects Update noting the positive progress that has been made to meet capital project objectives.

Complex Capital Projects Update

Mr. Scott Stewart, Deputy CAO of Infrastructure, Development & Enterprise Services, explained how the new Project Management Office has responded to Deloitte's 2014 assessment and recommendations on improving complex capital project risk management.

Mr. Stewart announced the launch of the web-based Complex Capital Project (Tier 1) Portfolio Dashboard and demonstrated its purpose of providing pertinent information regarding the progress of complex capital projects over \$10 million. A new Tier-1 Project Quarterly Status

report has also been created to supply detailed information on the status of projects, barriers to the project, and explanations for changes in the project time-lines.

Proposed Changes to Provincial Land Use Plans in the Greater Golden Horseshoe

Ms. Melissa Aldunate, Manager of Policy, Planning and Urban Design, provided an overview of the 'Planning for Health Prosperity and Growth in the Greater Golden Horseshoe 2015-2041' report developed by the Province's Advisory Panel on the Coordinated Review of the Growth Plan for the Greater Golden Horseshoe, the Niagara Escarpment Plan, the Greenbelt Plan, and Oakridges Moraine Conservation Plan.

Mr. Jason Downham, Planner II – Policy & Analytics, compared the changes to the growth and density targets for the City of Guelph from the former 2016-2031 targets with the revised 2016-2041 targets.

Ms. Aldunate proceeded to review each of the themes related to the changes in the Growth Plan including: Building Complete Communities, Supporting Agriculture, Protecting Natural Heritage and Water, Growing the Greenbelt, Addressing Climate Change, Integrating Infrastructure, and Improving Plan Implementation.
