## **Growth/Land Use Planning Workshop**

Todd Salter welcomed everyone and provided introductions and a brief overview of the purpose of the meeting. He provided a brief audio visual presentation by Jennifer Keesmaat called "Own your City".

Melissa Aldulante provided information regarding the Growth Plan for the Greater Golden Horseshoe, including planning principles and policies, targets, challenges and the coming Plan review.

Jason Downham reviewed the process for arriving at the City of Guelph Growth Management strategy and the findings.

Melissa Aldulante gave an overview of Guelph Official Plan 39 which is the City conformity amendment with the Growth Plan in effect since March 2010.

Jason Downham provided a Guelph progress report on conformity with the Growth Plan including forecasts to 2041.

Christel Gregson explained the history and purpose of development charges and the fact that development does not entirely pay for itself through development charges.

Todd Salter and Jason Downham reviewed the Greenbelt Plan and Growing the Greenbelt.

Council was also requested to complete a survey, of which the results would be shared with them.

Kate Bishop and Kelly Guthrie led Council through a table discussion on places to Grow and Growth.
