## COW-IDE-2017.1 Heritage Review (Removal) of 300 Water Street and 129 Surrey Street East from the Municipal Register of Cultural Heritage Properties

## **Recommendation:**

That staff be authorized to remove 300 Water Street and 129 Surrey Street East from the Municipal Register of Cultural Heritage Properties.

## COW-IDE-2017.2 Cart Capital Funding Source

#### **Recommendation:**

That \$150,000 from the Federal Gas Tax Reserve Fund be allocated to purchase waste carts for development growth in 2016.

## COW-IDE-2017.3 Sign By-law Variances for 33 Cork Street West

#### **Recommendation:**

That the request for variances from Sign By-law Number (1996)-15245, as amended, to permit a 2.16m<sup>2</sup> illuminated freestanding sign at 33 Cork Street West to be a height of 3.15m above the adjacent roadway and be located 23m from a freestanding sign located on an adjacent property, be approved.

## COW-IDE-2017.4 Sign By-law Variances for 370-374 Stone Road West

#### **Recommendation:**

- That the request for variances from Sign By-law Number (1996)-15245, as amended, to permit 2 menu boards, with a height of 2.39m above the adjacent roadway and sign faces of 4.6m<sup>2</sup> each on the property of 370-374 Stone Road West, be approved.
- 2. That the request for variances from Sign By-law Number (1996)-15245, as amended, to permit a 0.43m<sup>2</sup> illuminated freestanding sign on a height restrictor bar at 370-374 Stone Road West to be located 30m and 95m from freestanding signs on the same property, be approved.

#### COW-IDE-2017.5 Sign By-law Variances for 500-530 Willow Road

#### **Recommendation:**

- That the request for variances from Sign By-law Number (1996)-15245, as amended, to permit a 9.81m<sup>2</sup> illuminated freestanding sign at 500-530 Willow Road to be setback 4.04m, with a height of 8.22m above the adjacent roadway and to be located 65.9m from a freestanding sign located on the same property, be approved.
- 2. That the request for a variance from Sign By-law Number (1996)-15245, as amended, to permit a 2.16m<sup>2</sup> illuminated freestanding entrance sign at 500-530 Willow Road with a height of 3.24m above the adjacent roadway to be located 65.9m from a freestanding sign located on the same property, be approved.
