Background

- In 2016, the City Clerk's Office was tasked with conducting a Meeting Management Review (MMR).
 - City's governance structure was reviewed as part of MMR.
- April 25, 2016
 - Council approved a Committee of the Whole (CofW)
 governance model and directed staff report back with on
 MMR and incorporating the CofW model.
- June 27, 2016
 - Council directed staff to make necessary changes and implement CofW governance model and report back to Council after six months of implementation.
- CofW structure effective September 2016.

Anticipated CofW Improvements


- For The Public:
 - Ability to delegate at both CofW and Council
 - Day and evening options for delegations
 - Improved efficiency in Council meetings
- For Council:
 - Streamlined meetings focusing on recommendations
 - Fulsome discussion with all members present at CofW
 - Reduced duplication at Council meetings
- Resource efficiencies:
 - Fewer agendas produced
 - Less information items on Agenda (receipt only reports)
 - Reduced items on addendum via more timely preparation of report (improved OT)

Six-Month Review

- Direct comparison of the CofW system (September 2016 to February 2017) to the Standing Committee system (January to June 2016)
- Data taken from meeting and agenda statistics, resourcing statistics and survey results from all 13 Members of Council
- A full calendar year review will provide more data and will allow for more fulsome community engagement on the transition








Hours in Council Meetings

Do you believe the Committee of the Whole system has streamlined and simplified the Council decision making process?




Do you believe the Committee of the Whole system has improved the efficiency and effectiveness of the public delegation and correspondence process?




Do you believe the Committee of the Whole provides a simplified and predictable meeting schedule for members of Council and the public?



Do you believe the updated agenda format has made it easier to read and understand Council and Committee of the Whole agendas?




Do you believe the updated staff report template has made it easier to review and understand staff reports?






Do you believe the Committee of the Whole system has reduced the amount of duplication between Committee and Council?

Public Participation in Policy Development

The Key to Efficiency in Evidence-based Policy Development Is Community Engagement

Promoting an open and transparent government (1)

- A key feature of open government is effective community engagement that allows members of the public to influence policy decisions.
- As noted in Guiding Principles for Community Engagement early engagement and access to decision making are important principles.
- Delegating to COW and/or City Council after recommended actions are formulated is not effective community engagement

Promoting an open and transparent government (2)

- Major Changes in policy should always have a Community Engagement process completed before the change in policy is presented to COW.
- To confirm the requirement for Community Engagement in Major Changes in Policy this requirement should be added to Corporate Administrative Plan – Overarching Goals As:
- "Incorporating Community Engagement in Policy Development"

Promoting an open and transparent government (3)

- One of the decisions that should include Community Engagement is what to include in staff work plans.
- I am not aware of any structured opportunity for the community to influence the choice of issues needing attention in the next year.
- For example I see a need for consideration of a transfer of some or all of the GRCA lands in Guelph to the City for optimal management how can this be raised for consideration?

Example of Issues with GRCA ownership of land in Guelph

- The City and its citizens recognize "the significance of these spaces" (GRCA Lands) "within the City's open space system".
- 1) GRCA isn't comfortable providing a blanket letter allowing the City to name our properties or infrastructure (formally). We would ask to be consulted as needed.
- 2) Trails and associated infrastructure is considered municipal infrastructure- so you can name the trails as you see fit. In the case of the termination of the Maintenance Agreement, it is the City's responsibility to remove all infrastructures from GRCA lands (including trails).

Example of Issues in Crane Park Planning

- The current scope of work for Crane Park is to complete an EIS that will inventory where trails both formal and informal currently exist in the park, what natural heritage elements exist and where it would be appropriate to place trails within the park.
- Crane Park is located adjacent to Grand River Conservation Authority (GRCA) land that includes the Kortright Waterfowl Park, where a number of informal trails in Crane Park have alignments that enter onto GRCA lands.
- Currently the City has no agreement with GRCA to promote public access from City lands onto the GRCA lands.

Recommendation

Add to recommendation 4:

 "including consideration of improved guidance to staff on what types of items require Community Engagement prior to the item being placed on the COW agenda."
