With respect to the Staff Report:

While the Staff Report makes reference to the Niska Road Bridge Environmental Assessment (EA) study, staff further acknowledge the EA finding that a roundabout may have environmental impacts to the wetland and/or wetland buffer and may therefore be deemed unfeasible at this location.

If the traffic calming conceptual design for Downey Road is endorsed by Council, staff will review the intersection further at the time of detailed design to confirm if a roundabout is truly not feasible and to determine what can be an appropriate solution for traffic calming and traffic control at this location.



Further to the Municipal Election Modernization, Service Expansion and Ranked Ballot Election report, page six it states that:

In 2014, the successful candidate for the Office of Mayor received 19,627 votes or 50.75 per cent of the votes. This would fall just below the threshold of 50 per cent plus one and would have required a second round of vote counting to determine the successful candidate.

An amendment has been made to reflect this as:

In 2014, the successful candidate for the Office of Mayor received 19,627 votes or 50.75 per cent of the votes. This would fall above the threshold of 50 per cent plus one and a second round of vote counting would not have been required.

Pages seven to eight state that:

To put the multi-member ranked ballot election calculations for the Offices of Councillor into context, the threshold in the 2014 municipal election would have been 12,977 votes or 33.3 per cent plus one calculated as follows:

$$12,977 = \left(\frac{38,933 \text{ votes cast}}{2 \text{ candidates to be elected} + 1}\right) + 1$$

In the 2014 municipal election each successful candidate for Councillor received a range of between 2,050 (19.97 per cent) and 3,806 (33.46 per cent).

This means that both the Office of Mayor and each Office of Councillor would have been below the required threshold to be elected in the first round in 2014. Subsequent rounds of vote counting would have been required in order to determine the successful candidates for every office.

An amendment has been made to reflect this as:

To put the multi-member ranked ballot election calculations for the Offices of Councillor into context, the threshold in the 2014 municipal election would have been 33.3 per cent plus one.

In the 2014 municipal election only one Councillor in Ward six received enough votes to meet the threshold.

This means that the remaining 11 Offices of Councillor would have been below the required threshold to be elected in the first round in 2014. Subsequent rounds of vote counting would have been required in order to determine the successful candidates for those offices.

The above amendments do not impact the recommendations made in the report.

To the members of Guelph City Council,

For those who do not know 123Guelph is a citizen group that seeks to increase voter engagement and the effectiveness of elections in creating a council that accurately reflects and represents the population. We are part of a province wide network currently advocating for the adoption of Ranked Ballots. Provincial legislation has recently been updated to allow for the use of Ranked Ballots. However, as noted in the staff report from the Clerk's office, this process is not yet complete and the details of regulation and implementation have not been finalized. The current timeline and the required work to implement Ranked Ballots for 2018 are logistically daunting. 123Guelph believes that anything worth doing is worth taking the time to do well. As such we support the staff recommendation to wait for now. 123Guelph will continue to educate the public about the benefits of Ranked Ballots and we hope to make Ranked Ballots will be used for 2022.

123Guelph does not support the inclusion of a referendum question for 2018 as the public does not have enough information about Ranked Ballots to make an informed decision for or against such a proposal.

123Guelph also supports the staff report recommendations to expand voter accessibility via internet voting and vote anywhere options.

Written comments on COW-GOV-2016.2 Municipal Election Modernization, Service Expansion and Ranked Ballot Election

My comments focus on the proposed implementation of ranked balloting in Guelph municipal elections.

I disagree with the staff recommendations that the existing first past the post election model be retained for the 2018 election.

I recommend that Option a) "Pursue a ranked ballot election as an option for the 2018 election and go out for public consultation" be pursued.

The staff rationale for delaying the implementation of ranked balloting centre around increased cost, equipment testing and lack of current adoption.

Missing from the staff report is any analysis of the benefits of ranked balloting. A report that focusses only on possible costs and impediments to implementation, without touching on potential benefits is a report that is only telling part of the story. Seeing only costs and no benefits, it is not surprising that staff elected to punt this initiative down the road and adopt a "wait and see" stance in the hope that another, more adventurous, municipality would adopt it first.

Guelph is actually in a rather unique position among Ontario municipalities as it in one of the few that has multiple member wards. The combination of multiple member wards and ranked balloting is the Single Transferable Vote system, which has the advantage of being a more proportional system than the First Past the Post System currently employed. Increased proportionality is desirable as it allows a wider spectrum of opinions to be represented a council, and reduces the likelihood that a single faction could "sweep" an election and shut out any opposition. Probably the best known Canadian example of this was the New Brunswick provincial election of 1987 where the Liberals under Frank McKenna won 60% of the vote and 100% of the seats. If Guelph were to develop a party system, under the current FPTP multiple member system it is likely that voter will plunk down their 2 votes for the same party in each ward. Under the STV system it is more likely that the votes would be split between factions, with "non party" voters having more influence. Decisions on voting system choice follow from community values. Proportionality is a value, but there are many others. The discussion of values should come first, and the choice of a voting system than should follow on from that. This is why proceeding with public consultation should not be omitted from any decision.

The estimates of costs in the report overlook the fact that many of the quoted values are one-time costs that occur in the implementation phase and would not recur. Additionally, it is assumes that voting machines, that are not yet developed for our situation would be needed. In fact paper ballots with manual counting could be used (as they are in the Republic of Ireland), at considerable saving from the quoted figures. The main disadvantage of manual counts is that it would take longer to conduct. I recommend retaining a manual count as it provides a check on the machine's results. Our more paranoid citizens will accept no less.

Objectors to proportional systems may complain of increased complexity. Staff has aided them by providing examples of, vote transfers without any context. Implementing public consultation will help that. In fact ranked balloting is very simple to vote. FPTP is much harder because of the need to consider strategic voting, possible vote splitting etc. Counting in proportional systems is harder but the average voter never takes part in a count, either FPTP or STV.

There is much more to say about this but I don't have time, hence the need for public consultation.

Guelph is recognized as a leader in many fields. Bold action on this issue is a chance to add one more.
