Dear Madame Mayor and Members of Council:

I am coming to you as a citizen and not as an employee of the City of Guelph. After working for the City for a couple of years, I decided to move my family here as I truly believe that this City is one of the best in Canada.

I wanted to raise my children in a community that cares, that embraces diversity, is accountable to the next generation and is passionate for the environment.

I am a strong supporter of volunteering and I belong to a number of organizations in Guelph to do my part in keeping my community strong.

Unfortunately, since moving to Guelph my son has been mercilessly bullied at school which has included verbal insults, threats, physical assaults and a terrifying incident involving a knife. Words can't begin to describe what horrific acts have been thrust upon him, as much of it is too foul and too painful to repeat.

I have attached a piece of his writing based on his experience which has garnered a lot of attention both locally and nationally.

Because of his honesty and thought-provoking words, his writing has resonated with people across Canada. As a result, over the past few months, I have been a regular guest on the Roy Green Show, a nationally syndicated radio broadcast across Canada. I have been a strong advocate for my son and a voice for other children in similar circumstances. In December, I had a meeting with the Minister of Education, Laurel Broten to discuss the proposed changes to the *Safe Schools Act*, and to table some ideas around a collaborative community approach. I have also started to bring together local leaders to build a made-in-Guelph collaboration against bullying.

I didn't set out to carry the torch on an anti-bullying crusade, but I do believe that we are burdened in life with misfortune to inspire us to make change. To do nothing is not an option.

The World Health Organization (WHO) has declared bullying a "global social health problem" which has reached epidemic proportions. Seven children within a few hours from Guelph have committed suicide since September due to bullying. Recently, Jamie Hubley, the son of a City of Ottawa Municipal Councillor, took his life due to bullying. Suicide continues to be one of the leading causes of death among children under the age of 14. Suicide rates are continuing to grow among adolescents, and have grown more than 50 percent in the past 30 years.

Bullying is not just happening in our schools; it also occurs in our parks, arenas, etc. and yet, to date, all remedial action has been placed upon the school boards for correction. We are of the opinion that this is society's problem and therefore it MUST be resolved by society as a whole.

Research has shown that children who are chronic bullies without intervention grow up to have criminal records by age 28. Similarly, kids who are chronically bullied and left untreated, demonstrate antisocial behaviours and, oddly enough, both become non-contributing members of society. They draw on our medical system, social assistance programs and are a continued policing problem. The classic bully often continues the cycle of abuse in acts of domestic violence and, unfortunately, this is where the problem perpetuates itself; breeding the next generation of bullies. Victims of bullying too often become bullies out of sheer frustration and anger that no one was able to make it stop.

This social-economic problem and the cost of conflict in our society is a direct result of bullying. I am here today to ask for your assistance to make Guelph a safe community for our children. The City of Guelph has committed to a Community Wellness Initiative, and, in order for it to be successful, bullying needs to be address in a collaborative manner with other community stakeholder groups. This meaningful initiative must take into consideration the impact of bullying and how it diminishes the well-being of every Guelph citizen both young and old.

I am here today to request a Member of Council to be an active member on a newl-formed group: the Guelph Anti-Bullying Coalition.

This Coalition is made up of representatives from multiple community partners such as, Upper Grand District School Board, Guelph Police, Trellis, Family and Children Services, the John Howard Society, etc.. We hope to add to this list of keen community supporters but most importantly we see The Corporation of the City of Guelph as an integral partner of this team.


Our strategy is simple. We want to coordinate anti-bullying efforts in Guelph; establish clear, concise and consistent communications about bullying; and build community-wide expectations to address bullying.

This City's mantra is, "Making a Difference" and I would like the City of Guelph to Make the Difference and be the first City to publicly announce that we care for the future of our young people and we are taking a stance against bullying now. We need to work in an integrated way; to be the front-line against the war on bullying so that in every establishment in Guelph our message is loud, clear and consistent. We are the most caring community, we do "Make a Difference", and therefore, we are the best municipality in Canada to champion this message.

In the words of Margaret Meade, "Never doubt that a small group of thoughtful, committed people can change the world. Indeed, it is the only thing that ever has."

So please, join our Coalition and be an active partner to make Guelph a safe community for our children.

#### He's not 'just a boy,' he's very special

I was out for lunch with some friends a few days ago and our conversation turned to our children. Most of our conversations do.

One friend began to tell us about the struggle that her son is having. He's in Grade 8 in our community. She shared with us a piece of writing he had produced.

She had asked him to write a pro and con list about going on his school's Grade 8 graduation trip. But for a spell-checking, this is what he wrote:

I am just a boy who didn't have any choices about the hell I have endured.

I am just a boy who couldn't wait to go to school and learn and be liked.

I am just a boy who wanted to make friends and be part of the team.

I am just a boy who didn't get to realize this dream.

I hope when individuals hear a person mocking another they have the strength and courage to stand up and say that is not OK, no matter what the situation is.

I want to thank this young man for letting me share this beautiful piece of writing with our community. I want to tell him he has a very strong voice. The act of writing is powerful. He is beautiful. He is strong. He is a very special boy.

### 'Just a boy' poem spurs big response

I thought it was too good to be true.

I thought it was too mature to be true. I thought it was too polished to be true. I thought it was too eloquent to be true.

That's part of the reason I told Susan Farrelly of our Community Editorial Board I would not publish the anonymous poem she had crafted a http://www.guelphmercury.com/opinion/columns/article/543445--he-s-not-just-a-boy-he-s-very-specialcolumn around this month—unless and until I could meet the poet. According to her, he was a local junior high student.

Newspapers have to be guarded in using material—any material—from confidential sources. This paper has several written policies on this point since erring on the use of such sources can corrode a publication's credibility. Exceptions are rare within our policies.

Farrelly helped arrange a meeting for me and the poet and his mother.

Before we met, I ran passages of his 28-line 'I'm just a boy' poem through a bevy of databases and search engines. It seemed original. Then, when I met him, it took little time to be persuaded both the poem and the exceptional young man who authored it were the real deal.

He's been through an awful lot. He's incredibly articulate. He's a gifted writer.

So, the Mercury published Farrelly's column built on his poem about coping with isolation and bullying. It appeared June 6 in the newspaper and on our website. The reaction to it has been immense, moving and incredible.

Online, the column has gone viral. It has spurred online comments, copious recommendation-clicks and several emails to our newsroom and to Farrelly.

In the paper, the poem has spurred a http://www.guelphmercury.com/opinion/letters/article/547412--we-must-be-alert-to-the-needs-of-our-childrenletter from a grandmother, Gloria Ferringo, who wrote that it brought her to tears. It also moved her and others to call for action to better support such victims.

Gateway Drive Public School teacher Lesley Brownlee shared the poem with several classes at her school.

"In all the classes I read it to, you could have heard a pin drop. This one class absolutely melted," she said.

All the classes exposed to the poem were then guided to discuss it. Those conversations surprised and moved Brownlee.

The class that "melted" was a Grade 4/5 split. Its students' talk led to action. The class created tiny signs bearing the phrase 'Be excellent to each other,' and started posting them up. The signs went up in the classroom, then in washrooms, hallways and even the school's office.

"It really went way beyond what I expected," Brownlee said. "The signs went up all over the school."

I asked Brownlee, the school's French teacher, if she will incorporate the poem in future teaching.

"I'm not going to throw it out. Put it that way," she said.

It was moving and inspiring to speak with her.

Farrelly, a Rotarian, was thanked out loud at her last Rotary function for sharing the poem and related messages in her column. She has also been approached by a Guelph Catholic school seeking consent for the column to be used in its social justice program and by an organization affiliated with the University of Guelph that works with children with various disorders. That organization also wants to use the column as a resource.

I've stayed in contact with the poet's mother. She originally passed along the poem to Farrelly and other friends without her son's knowledge and without a notion it might become public—let alone this public. It came about out of her urging her son to make a pro-con list at home to help him decide whether to attend a Grade 8 graduation trip. Instead of the list, he wrote the poem.

I hope he continues to write—perhaps for the Mercury—as the exercise can be empowering and healthy and cathartic. He's a good writer—but not too good to be true.

### Guelph woman to be on provincial bullying task force

GUELPH — A Guelph mother of a child who has been bullied hopes to serve on a task force with the Minister of Education that's examining bullying and ways to eliminate it.

MacIntyre is a single mother with children in the education system. One of her children has experience various episodes of bullying. She said the acts have been both subtle and overt, physical and verbal, but what's been so confusing for her and her child is the inconsistent way it has dealt with, principal by principal, school by school and board by board.

Consequences for the bully are also inconsistent, and even the definition of what constitutes bullying is a moving target, she said.

"And this is not just a school issue — it's a societal issue," MacIntyre said. "Many kids who bully are in the criminal justice system by the time they are 28. Many kids who are bullied wind up with depression and other mental health concerns later in life.

"Bullying changes kids. It makes eight-year-olds have suicidal thoughts. We need to do better for our children."

MacIntyre has become a champion for affecting change against bullying as a result of her family's experience with the problem.

This year she has often been a guest on The Roy Green Show, a nationally syndicated Canadian talk radio show. On the program, she's voiced her opinion on bullying and it was through the show that she connected with Broten.


Broten's task force follows Premier Dalton McGuinty's announcement last month that his government intends to tighten up bullying legislation to give principals and school boards the power to expel bullies. This follows some recent cases of young people who took their own lives because they felt powerless in the face of bullies at school.

"Canada's criminal code and school board policies should be aligned," MacIntyre said. "There's more protection for people in the workplace than there is for kids in the schoolyard."



## Challenges



# **GUELPH FEE CHANGES FOR 2012**

In 2012 Guelph is discontinuing the use of the all inclusive pass. By doing away with these passes, those of us who use the facilities on a regular basis are finding the fees increasing enormously. The best prices for seniors who are frequent users of the facilities in 2012 are as follows:

Yearly Active Living Pass for fitness Room and Lane/Leisure Swims	\$ 368.62
Aquafit Punch Card (for 40 aquafit classes)	\$162.57.
Fitness Land Classes (approximate cost/1 class of 12 weeks duration)	\$127.19.

# **IMPACT OF NEW COSTS**

Below are some calculations for different types of users of City facilities.

FINAL NOTE: Even those communities/facilities who do not offer an all inclusive pass are cheaper than Guelph. To discontinue these passes seems to be discouraging wellness and an active lifestyle which the City is supposed to promote. In the last Guelph Community Guide (Fall 2011 and Winter 2012) the Mayor and the Executive Director of Community and Social Services stated that the City offers "fun, affordable recreation activities". This can no longer be said as these prices have now become unaffordable.

#### Dear Councillors,

I would like to bring to your attention that these new fees for usage of the recreational centres are way out of line. I am a senior that has used the West End Rec Centre since it was built, and I each year have purchased the yearly Active Living Plus package. This package allowed the usage of all the facilities. The cost was \$419.42 for one year. I attended the Town Hall meeting on Feb 1 at the West End Rec Centre to talk to some of the councillors that were able to come. Cam, Gloria, Andy were kind enough to hear some of my concerns, about were the city was headed with these new fees. The following is a list of how much it will cost me for the same activities that I was doing with the Active Living Plus package.

aquafit 3 times a week X 50 weeks = $150$ /year at \$162.72 per 40 v	visit = \$610.20
fitness room 10 visit	= \$ 57.16
post rehab 10 visit	= \$ 48.61
public swim 10 visit	= \$ 32.50
GrandTotal	= \$ 748.47

As you can see this is \$329.05 more than what I was paying before or 78.5% more. I can understand raising the fees by the cost of living. But this increase is absurd and unmanageable to say the list, especially for somebody that is on fixed income. I would hope that you will address this issue in your next meeting, otherwise I will be forced to look at other options which may include discontinuing to attend the City Rec Centre.

# **SUMMARY**

The purpose of this report is to provide an overview of recent changes to the recreation passes offered at City facilities and to summarize the communications strategy to date.

#### **BACKGROUND**

Affordable rates paid by users help to cover the costs of operating high quality recreation programs and facilities. Guelph continues to offer recreation passes, which provide affordable and flexible options for adults of all ages, abilities and interests.

Upon evaluating several recreation programs rates and fees, the City moved to discontinue its Active Living Basic, Active Living Plus and Smart Start recreation passes. The passes had relatively few users, did not cover program costs and posed certain security issues in the facilities. While these three passes are no longer being sold, existing passes will be honoured for the remainder of the year, until they expire.

#### REPORT

Residents with Active Living Basic, Active Living Plus and Smart Start recreation passes purchased last year can now choose from new affordable and flexible options. The City now offers 10, 20, and 40-visit punch passes in an effort to improve uptake and cover costs. The Active Living Pass and the Active Living Rehab Pass are also still available.

For residents on fixed or low income, the City offers the confidential Fee Assistance in Recreation (F.A.I.R.) program. Individuals who qualify can receive discounted recreation programs, swim passes, or selected memberships. Applications are available at all recreation centres or online at guelph.ca/recreation.

Feedback has been received from a small number of existing pass-holders, and their comments have been mixed; depending on how they were previously using the pass and how often they were participating in programmed classes, some patrons have found that their costs have decreased under the new system. For other patrons, specifically those who were attending multiple classes each day and/or week, they have found that their costs have increased.

One of the primary distinguishing features of our recreation and community centres is that they are designed to be broad based in the services that they provide, and provide universality in access to our residents. Other athletics clubs or facilities function on a membership basis, where the only option is for people to buy an all inclusive membership pass – this can be very cost prohibitive for a large portion of our community. Instead, our facilities operate on the principle that users pay on a per program basis, enabling people to participate in the number and frequency of programs that best meets their needs. As such, it is not financially or operationally sustainable for us to continue offering broad based all inclusive passes.

We are committed to continuously evaluating our program offerings to ensure that we are being responsive to user feedback. Staff will continue to monitor feedback received from our client base, and will take that feedback into consideration when planning future programming and/or pricing and pass options for our recreation facilities.

As part of the 2012 work-plan, staff will be undertaking a broad review of all the rates and fees within the Community and Social Services department, and the feedback that we've received on our recreation pass structure will form an integral part of this review.

#### FINANCIAL IMPLICATIONS

The 2012 budget projections included a 3% increase to all overall recreation revenues. The expectation was that any loss in revenue from the elimination of the passes would be offset by an increase in revenue through new users attracted to the increased flexibility provided by the punch passes.

#### COMMUNICATIONS

A comprehensive communications strategy was put in place to ensure all pass holders were informed about the changes. Notices were posted in all recreation centres, all existing pass holders were sent letters informing them of the change, the information is available on the City's website, and pass holders will continue to be informed and updated of the changes if they opt to purchase a new pass when their existing pass expires.

A broad communications campaign will be rolled out in the coming months to market the new punch passes to those residents for whom the previous passes were not meeting their needs, and to promote the new more flexible punch passes. Through this marketing effort, we expect to reach a broader number of residents and increase the number of clients using our recreation facilities and programs.

### **SUMMARY**

# **Purpose of Report:**

To update Council on the request for an increase in current funeral service rates for social assistance recipients and low income individuals paid on behalf of the City by the County as the Consolidated Municipal Service Manager for Social Services.

#### **Committee Action:**

To approve the recommendation that 2012 funeral service rates paid for social assistance recipients and low income residents be increased by 20% to align with the 2012 County of Wellington Funeral Directors Fee Schedule and to more closely reflect actual costs for funeral services.

# **RECOMMENDATION**

THAT City funding for non-prescribed (discretionary) social service funeral rates be increased by 20% retroactively to January 1, 2012 to align with the County of Wellington's Funeral Directors Fees and to more closely reflect actual costs for funeral services;

AND THAT the process for subsequent rate increases be negotiated as part of an agreement on social services between the City and County of Wellington as Consolidated Municipal Service Manager.

#### **BACKGROUND**

Wellington County, as Consolidated Municipal Service Manager (CMSM) for social services (i.e. Ontario Works, social housing and child care), administers a number of non-prescribed (discretionary) social service programs which are not mandated

by provincial legislation. Some non-prescribed programs receive provincial and/or federal subsidies, some are funded jointly by the City and County, and others are funded solely by either the City or the County. The City and Wellington County are currently in negotiations on the delivery of all non-prescribed social services by the County in their capacity as CMSM. These negotiations are outlined in report # CSS-CESS-1139.

Funeral services are one of the non-prescribed programs. These services are provided for social assistance recipients and low income individuals. The cost for social assistance recipients is cost shared with the province (82.8% covered by the province, 17.2% by the municipality). Costs for low income residents are 100% funded by the City. In both circumstances, the County pursues all possible reimbursements from the deceased person's estate (e.g. bank accounts, CPP Death Benefits, etc.).

The specific costs and historic funding arrangements for funeral services are outlined in the County of Wellington Social Services Committee Report dated October 13, 2010. The County's report responded to a request from Funeral Directors for a 20% increase in funeral rates for 2011 and 2012 respectively. In this report, the Special Services Manager noted that "funeral rates were increased significantly in the early 1990's. Since that time the yearly increases have been minimal and have not accommodated the increases experienced by the funeral homes." Cemetery costs, currently capped at \$1,000, are in addition to the negotiated funeral service rates.

Prior to the request for a rate increase, the County paid \$3,321 per funeral service. According to information submitted by local Funeral Directors, the average public rate for funeral services is \$5,303. The difference between social assistance and public rates is \$1,982.

#### REPORT

Following the County of Wellington's October 13, 2010 Social Services Committee Report, County Council approved a 20% increase in funeral rates for 2011 and an additional 20% increase for 2012. In a letter dated November 3, 2010, the County formally requested that the City "determine the extent to which the City is prepared to fund the cost of discretionary funeral services on an ongoing basis".

In report # CSS-CESS-1115 (dated May 10, 2011), staff recommended to maintain the rates at status quo. On June 27, 2011, City Council directed staff:

"THAT Report # CSS-CESS-1115 "Discretionary Social Services Funeral Directors Fees Update", dated May 10, 2011 be received;

AND THAT the City funding for 100% municipally-funded discretionary funeral services be increased by 20% to align with the County of Wellington's Funeral Directors Fees funding with the funding be retroactive to the beginning of 2011."

Council's resolution increased funeral rates by \$664 per service to a total of \$3,985 effective January 1, 2011.

In 2011, the total cost of funeral services was \$47,135. Thirty-one funerals were covered at an 81.2/18.8 cost share for the amount of \$23,225 and six were 100% municipally funded for a cost of \$23,910.

It should be noted that the Ontario Works' basic financial assistance costs will be uploaded to the Ministry, effective in 2018. This upload includes the cost of funeral services for social assistance recipients. Originally, the cost of this benefit was shared 80/20 with the province. In 2012, the cost-sharing ratio has been amended to an 82.8/17.2 split. Municipalities will continue to fund 100% of funeral services costs for low income individuals not receiving any form of assistance.

Staff recommends that funeral service rates be increased by 20% effective January 1, 2012 to align with the County contribution. The requested increase is \$797 per service for a total cost of \$4,782. This increase will reduce the difference between social service and 2010 public funeral rates to \$521.

#### CORPORATE STRATEGIC PLAN

#### FINANCIAL IMPLICATIONS

The 2012 provincial cost sharing rate of funeral services for social assistance recipients is 82.8/17.2. Municipalities fund 100% of funeral service costs for low income residents.

If the rate increase is approved, based on 2011 data, the City's estimated funeral service costs for 2012 are:

Cost shared: 31 funerals  $x $4,782 \times 17.2\% = $25,498$ 100% municipal: 6 funerals x \$4,782 = \$28,692

**\$54,190** (total)

The total financial impact resulting from a 20% increase for 2012 funeral service rates is \$9,032. This amount was included in the approved 2012 City budget. The County's preliminary 2012 social services budget, which was presented to Council on November 17, 2011, included the increased rate.
