785 York Road (Guelph Correctional Centre)

Listed property

Staff update on (Draft) Cultural Heritage Resource Impact Assessment required for York Road Environmental Design Study.

Staff resource: Arun Hindupur (Engineering)

- Stephen Robinson reviewed images and drawings depicting the proposed retention and relocation of the stone wing walls at the main entrance to former Guelph Correctional Centre
- Walls proposed to be carefully dismantled and moved back from the widened road eliminating the need for guardrails. The relocation would would reveal more more of the original stone wing walls
- Area is part of the GID Secondary Plan
- Discussion around the realignment of the creek
- Stephen reviewed further elevations explaning that most heritage features will be retained in situ through the road widening and realignment of Clythe Creek

- Suggestion that consideration be given to ensure periodic water flow over the most significant creek waterfall features
