### **EXECUTIVE SUMMARY**

### SUMMARY OF REPORT

This report is to inform Council that the 11<sup>th</sup> annual Clean and Green Community Clean-up (Clean & Green) event will take place on Saturday April 26, 2014 from 8:30 am to 1:00 pm. This includes the clean up activity as well as a volunteer appreciation barbeque at Riverside Park.

### **KEY FINDINGS**

2014 is the 11<sup>th</sup> annual Clean and Green Event in the City of Guelph. This is a successful volunteer community event that has removed over 29,500 kilograms of litter from the City over the last ten years.

### FINANCIAL IMPLICATIONS

Costs have been accounted for in the 2014 Operating budget.

### BACKGROUND

The Clean and Green Community Clean-up (Clean & Green) event is a volunteer community beautification initiative that takes place annually on, or near, Earth Day. The event originated as a collaborative effort by the City of Guelph, the Guelph and Wellington Development Association (GWDA), the Guelph and District Homebuilders Association and Guelph Downtown Business Association, to address the accumulation of litter that occurs over the winter months in parks, roadways and major entrance points to the city.

The Clean & Green event first began with approximately 40 volunteers working in teams to pick and bag garbage at ten key locations in the city. City staff provided volunteers, vehicles, supplies, promotion, disposal resources and fees, while the GWDA provided volunteers, vehicles and hosted a volunteer appreciation barbeque. Since its inception in 2003, thousands of volunteers have successfully removed over 29,500 kilograms of litter from our city's roadsides and parks.

The event has grown in popularity over the years and 2013 saw over 954 volunteers cleaning 94 locations, and collecting over 3,600 kilograms of litter. See Chart 1: Clean and Green Results, which illustrates the increase in litter collection and participation over the last few years. Note: In 2013, the event experienced freezing temperatures and snow which contributed to lower participation and kilograms of litter collected.




Chart 1: Clean and Green Results

- Once registered, volunteers will be provided with supplies and lunch tickets

- Coloured garbage bags will be used for identification and are a visible symbol of the cleanup efforts
- Solid Waste Resources Dept will provide curb side collection the same day
- Volunteers will be asked to select a cleanup location from a list of predetermined sites throughout the city to ensure key areas are addressed
- Blue bags are being provided to collect clean, dry recyclables
- The volunteer appreciation barbeque will be held in the large picnic area of Riverside Park.
- Sponsorship of this event has been secured by:
  - Tim Horton's will provide in store advertising, gloves, reusable travel mugs, product for the barbeque and draw prizes
  - M&M Meats will provide the food for the barbeque at a discounted cost.
  - Bag Ladies (Al-Pack Enterprises Ltd) a local Guelph company, will coloured garbage bags
  - o Guelph and Wellington Development Association will contribute towards the cost of the appreciation barbeque
  - o Terra-View Homes will contribute towards the cost of the appreciation barbeque
  - o Zehrs Imperial Rd (Loblaws) will provide food for the barbeque
  - o Guelph Downtown Business Association will provide draw prizes

In the end, the Clean & Green event remains a true volunteer community beautification cooperative of which the entire City can be proud.
