Introduction

The City of Guelph's commitment to Accessibility compliance is firmly aligned with the Accessibility for Ontarians with Disabilities Act (AODA). The organization strives to identify, prevent, and remove barriers to accessibility in key areas such as customer service, information access, public transportation, employment, and public spaces. With a focus on meeting and exceeding the standards set by the Integrated Accessibility Standards Regulation (IASR), the City of Guelph ensures that its policies and multi-year accessibility plan are not only up to date but also publicly available, reflecting a transparent and inclusive approach to accessibility.

Achievements

Several projects took place during 2023 that either incorporate accessibility requirements or were completed because of the City's commitment to equitable in its services, programs, and facilities.

- Riverside Park: bandshell renovations and new trails
- Margaret Greene Park new splash pad
- Annual Play Equipment Lifecycle Project
- Complete Streets Design Guide: Proposed Pedestrian and Cyclist Crossing

Transit and taxis: conventional services, bus stop design, taxis

Review of bus stop with shelter design in the Linear Infrastructure Standards

On-street parking relating to the following

- Downtown Guelph Parking Master Plan to include accessible parking at the planning stage and throughout the development of the plan
- Complete Streets Design Guide Project
- Seasonal Patio Program to minimize impacts to the accessible parking in the downtown during patio season
