



Thank you for your emails of May 10 and May 19 concerning the items that you raised at the second CLG meeting for the Guelph Wastewater Treatment and Biosolids Management Master Plan. The May 10 email provided your memo and spreadsheets concerning your review of the per capita flow rate and inflow and infiltration (I/I), and the May 19 email provided references concerning chloride levels from WWTPs.

Concerning your memo on flows, per-capita flow rates and I/I, Jacobs also compared per capita flow rates from the Guelph WWTP with those from Waterloo Region's larger WWTPs and found them to be in a similar range. From 2015 to 2019, the per capita flows for the larger WWTPs in the Region of Waterloo varied from 270 to 403 L/capita day on a yearly basis which compares well to the 390 L/capita/d rate we are using for Guelph. In addition, recent data indicates (Figure 1 from your memo) that the per capita flow rates for Guelph in the last ten years have been relatively flat, which is the period that Jacobs used to estimate the future per capita flow rate. Also, the Region of Waterloo uses student and under coverage populations (i.e., those missing from the Census data) in their estimate, which are not used by the City of Guelph. This likely introduces variations between per capita flow rates in the Region and the City. You do note that the water supply flows are lower than the wastewater flows, although this is the case for both Guelph and the Region of Waterloo.

The main issue that is raised in your memo is the wastewater and water supply per capita flow rate difference, which you have attributed to increasing I/I in the City. Our Team is not familiar with calculating the groundwater-derived I/I using the method from your spreadsheet (based on representative creek base flows and various infiltration factors). To estimate groundwater-derived I/I within the City, extensive flow-monitoring data are required, and these values would be calculated for catchments within the City, rather than one value for the entire City. However, your conclusion that the I/I rate has increased at a greater rate (12% per year) since 2013 is noted.

A review of the dry weather I/I in the City does require further evaluation and we have forwarded this information to the Water and Wastewater Servicing Master Plan team for their input and feedback. Regarding the impact to this Master Plan, the short- and mediumterm upgrades that have been identified are required regardless of the current flow forecasts for the City, as many are based on current flows and conditions. A review of the I/I can be planned and undertaken with care over the next number of years to get a better understanding of future projections. In addition, as discussed at the CLG meeting, a reduction in dilute flows to the plant (like I/I) would have no impact on contaminant loadings to the Guelph WWTP, which are the main factors in determining the capacity needed for many of the processes at the plant. It is also noted that a conservative approach is required for the Master Plan so that the City is prepared for and can budget capital expenditures required in the future. If I/I and per capita flow rates do in fact reduce in the coming years, then the impact will enable deferral of some planned capital expenditures. However, it is not possible to accurately predict the impact of any I/I reduction at this stage, so it

T 519-822-1260 TTY 519-826-9771 is necessary to use the per capita flow rate that was developed based 10-years of historical flow and population data.

The chloride references highlight the impact of chloride, especially from water softeners on the effluent chloride concentration from wastewater treatment plants. The references generally recommend addressing elevated chloride concentration at the source and not in the wastewater treatment plant (for example, through sewer use bylaws). Reductions at the source require changes to water softener practices and processes at residences. Removal of chloride at the wastewater plants is indicated to be difficult and very costly. The City undertook a study with the Region of Waterloo in 2016 (Environmental Impact Study of Residential Water Softeners for the City of Guelph and Region of Waterloo) to review the impact of water softeners. Some of the main points were:

- Current and future salt mass loading by residential water softeners were calculated to be 5,600,000 kg/year at present to 7,200,000 kg/year in the future for the Guelph WWTP.
- Current and future effluent concentrations attributed to water softeners range from 132 to 578 mg/L for chloride.
- Results from 2015 indicated that urban residential softeners contribute approximate half of the wastewater effluent chloride concentration.
- The recommendation was to move to a salt and water free softener technology recommendation was 100% replacement with ion exchange softeners over a 10 year period.

Lastly, the City is currently reviewing its sewer-use bylaw limits. the current limit for chloride is 1,500 mg/L. Jacobs will communicate with the progress of this project in terms of any reductions in chloride limits. Currently, upstream of the WWTP the chloride concentrations are around 60 mg/L, the effluent from the plant has a chloride concentration of around 500 mg/L, modeling estimates the downstream chloride concentration 220 mg/L at the WWTP's design flow.
