Rules and Regulations for Guelph's Bike Month Bingo Contest

Entry in this Guelph Bike Month Bingo contest ("Contest") constitutes acceptance of these contest rules and regulations.

1. Eligibility

In order to be eligible for this Contest, entrants must be 18 years of age or older and a resident of the Guelph and a permanent resident of Ontario. Contest entrants under 18 years of age must be represented by a parent or legal guardian. The Corporation of the City of Guelph ("City") employees, elected officials, and their immediately families are not eligible to enter. The City reserves the right, in its sole discretion, to require proof of identity and/or eligibility in a form satisfactory to it, to verify the eligibility of an entrant. Failure to provide proof to the satisfaction of the City may result in the disqualification of the entrant, at the sole discretion of the City.

2. How to Enter

No purchase necessary. Limit one (1) Contest entry submission per person by any method. There are two (2) ways to enter:

To participate in the Contest, visit www.guelph.ca/bikemonth to download the Guelph Bike Month Bingo card ("Bingo Card"). You are responsible for printing the Bingo Card. At your own pace and by choosing your own activities, complete activities on the Bingo Card. As you complete activities cross them off on the Bingo Card. Once you have completed five (5) activities in a row (across, up and down, diagonally), claim bingo. To claim bingo, submit your first and last name, email address, completed Bingo Card and photos of the five (5) activities within a row completed for the Contest to nolan.kelly@guelph.ca.

If you do not wish to participate in the Contest activity, you may still enter this Contest by submitting your first and last name and method of contact (email address or phone number) to nolan.kelly@guelph.ca or by mail to Communications, City Hall, 1 Carden Street, Guelph, ON, N1H 3A1. All entries by mail must be postmarked by June 27, 2023 and received during the Contest Period.

3. Contest Period

The Contest starts on June 1 at 8:30 a.m. EDT and ends on June 30, 2023 at 11:59 p.m. EDT ("Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

4. Photos

All photo entries must be photographs taken within the City of Guelph. Contest alteration of photo submissions is not acceptable, including combining multiple

photos. Cropping on photos is permitted, tonal or colour corrections are acceptable. Borders, frames, text or other graphic treatments are not permitted. Entrants must own all rights to the photographs submitted. As such, entrants hold the City, and all of its successor corporations and entities and their respective, past, present and future, elected and appoint officials, officers, directors, representatives, employees, servants, agents and their respective successors and assigns (collectively "Representatives"), harmless from any breach of copyright. Photographs that have won any other contests or have been published in a magazine or newspaper (except online) are not eligible. For a photo in which a person is recognizable, photo consent is required. Photo consent releases are the responsibility of the entrant and must be presented in the event the photo is a winner.

5. Disqualification

The City may disqualify any entry that:

- a. Is inappropriate, incomplete, illegible, damaged or irregular;
- b. Was submitted by illicit means; or
- c. Does not conform with or satisfy these rules and regulations.

6. Limitation of Liability

The City and all of its Representatives will not be responsible for any lost, stolen, delayed, damaged, misdirected, late or destroyed entries or for any typographical, printing, production, distribution, advertising or other errors or omissions with respect to this Contest.

7. Prize

There are a total of sixteen (16) prizes to be won:

- First prize: \$300 Gift Certificate to Speed River Bicycle (approximate value \$300)
- Second prize: \$200 Gift Certificate to Flow State Bike Co. (approximate value \$200)
- Third prize: \$200 Gift Certificate to Backpeddling (approximate value \$200)
- Fourth prize: \$200 Gift Certificate to Paramount Sports (approximate value \$200)
- Ten (10) Fifth prizes each consisting of a \$100 Gift Certificate for Downtown Dollars to any business or restaurant in downtown Guelph from the Downtown Guelph Business Association (approximate value \$100 each)
- Two (2) Sixth prizes each consisting of a \$50 Gift Certificate for Downtown Dollars to any business or restaurant downtown Guelph from the Downtown Guelph Business Association (approximate value \$50 each)

8. Winner Selection

Chances of winning depend on the number of eligible entries. Prizes will be awarded by a random draw from eligible entries on Thursday, July 6, 2023 at approximately 2:00pm ("Draw Date") in Guelph, Ontario. Prizes will be awarded in the order that the names are selected. Following the Draw Date, each selected entrant will be notified by email provided (or phone if applicable) with further instructions on how to claim the prize. Each entrant whose entry is drawn must provide satisfactory proof of identity (ie: government issued identification), answer a skill testing question and sign a waiver and release, provided by the City, in advance of, and as a condition of, receiving the prize. Prize winners have ten (10) business days from the date of such notification to claim their prize before they are disqualified and forfeit the prize. The City reserves the right to select an alternative entrant from the remaining eligible entries in which case the provisions of this section shall apply to such new selected winner. Winner(s') names and/or photographs may be published across the City's social media channels and other marketing publications. The City reserves the non-exclusive right to publish any entry and/or use any entry in promotion and advertising materials. The City reserves the right to request promotional rights from the entrant for the purpose of additional marketing.

9. Copyright Notice

With regard to any photograph(s) submitted, the entrant, or the owners of copyright to the photograph, retains copyright. By submitting any photograph to the promotion, the entrants grants (or warrants that the owner of such material) expressly grants to the City a royalty-free, worldwide, perpetual, non-exclusive license to display, distribute, reproduce, and create derivative works of entries, in whole or in part, in any media now existing or subsequently developed, for any purposes, including but not limited to advertising and promotional materials including its social media platforms and website, exhibition, and commercial product, including but not limited to City publications without compensation or additional approvals in connection with such uses. Winning entrants are required to sign a release containing the above conditions.

10. Abide by the Rules and Regulations

Each entrant agrees to abide by all the Contest rules and regulations. If there is any doubt as to the eligibility of an entrant or the manner in which an entrant wins a prize, the City, in its sole discretion, will decide the issue and its decision will be final. Entrants using any scheme, information or method to win a prize which, in the sole opinion of the City, is other than a fair chance, will be disqualified and lose the right to claim a prize to which they otherwise would have been entitled. If after the

awarding of the Contest prize a Contest winner is disqualified or determined to be ineligible, an alternate winner will be selected using the same process described above. Alternate winners are subject to all requirements set forth in these rules and regulations. The City has the right to interpret these rules and regulations as required and its decisions are final. The City reserves the right to cancel the Contest or modify these rules and regulations at its discretion without prior notice or obligation.
