City Council will hold a Statutory Public Meeting in accordance with the Planning Act on a Zoning By-law amendment application received from Black, Shoemaker, Robinson and Donaldson Limited on behalf of the owner, Knight Lumber Limited for the lands municipally known as 7 and 9 Omar Street and 19 Alma Street North.

Meeting Date: Monday July 8, 2019

Location: Council Chambers, City Hall, 1 Carden Street

Time: 6:30 p.m.

Subject Lands

The subject lands are located at the south-east corner of Omar Street and Alma Street North. The lands are approximately 0.2443 hectares in size with approximately 30 metres of frontage along Omar Street and approximately 55 metres of frontage along Alma Street (see Schedule 1 - Location Map).

Purpose and Effect of Application

The intent of the application is to change the zoning from the "Industrial" (B.4) Zone to a "Specialized Residential Single Detached" (R.1D-?) Zone to permit the development of two new single detached residential dwellings and the redevelopment of the two existing single detached residential dwellings. Future Consent applications to the Committee of Adjustment will be required to separate the subject lands into separate parcels.

The proposed conceptual site plan is included in Schedule 2.

Purpose of the Meeting

The purpose of the meeting is to provide more information about the application and is an opportunity for public input. No recommendations are provided at the Public Meeting and City Council will not be making any decision at this meeting. A recommendation report will be prepared and presented at a subsequent meeting of City Council following a full review of the application.

Other Applications

The subject lands are not subject to any other application under the Planning Act.

- i. If a person or public body would otherwise have an ability to appeal the decision of Guelph City Council to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Guelph before the by-law is passed, the person or public body is not entitled to appeal the decision.
- ii. If a person or public body does not make oral submissions at a public meeting, or make written submissions to the City of Guelph before the by-law is passed, the person or public body may not be added as a party to the

hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

Requirement for Owners of Multi-tenant Buildings

Upon receiving this Notice, owners of multi-tenant buildings with seven (7) or more residential units are required under the Planning Act to post this Notice of Public Meeting in a location that is clearly visible to all tenants (i.e. building or community notice board). The Notice shall remain posted until the day after the Public Meeting (July 9, 2019).

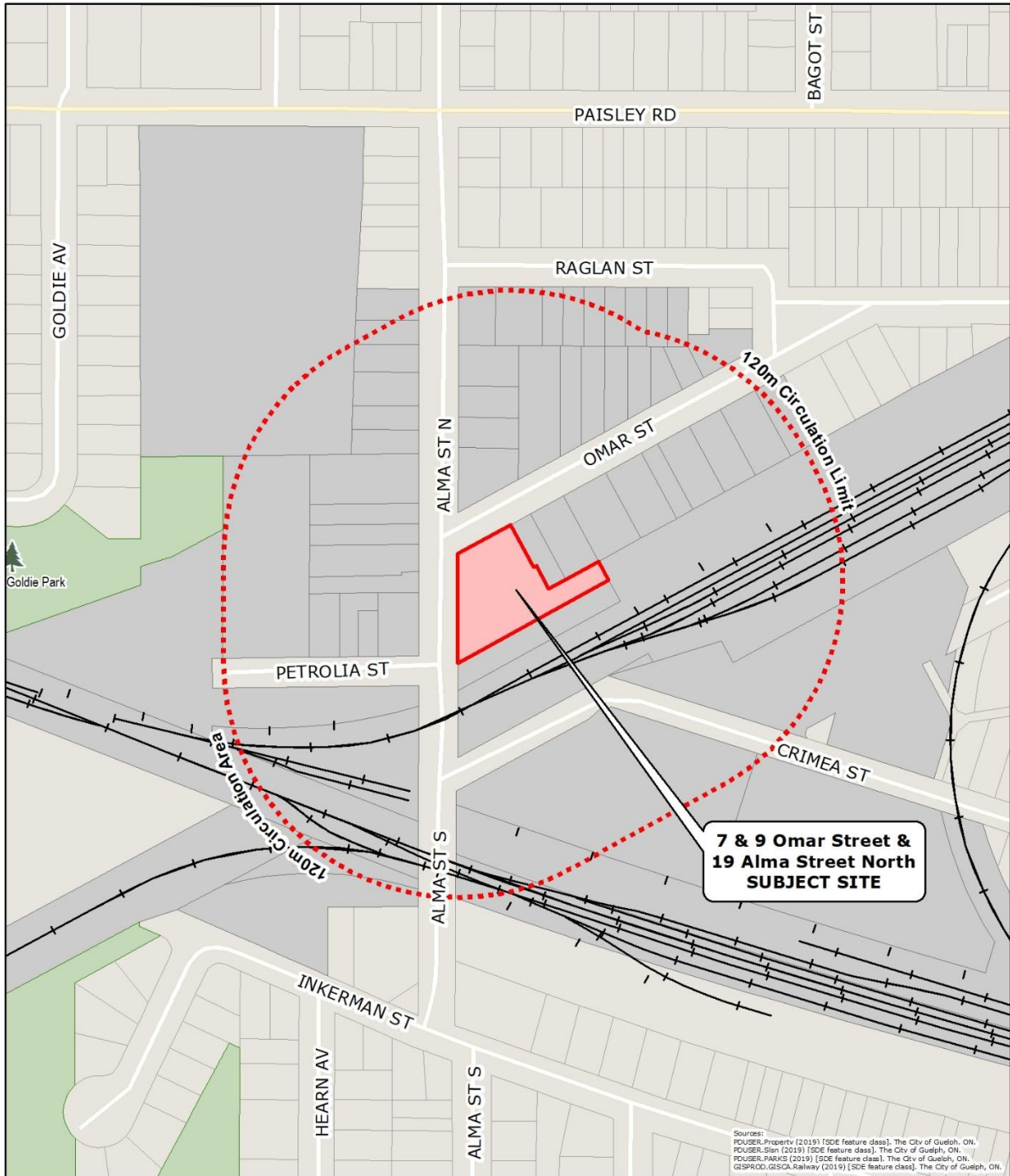

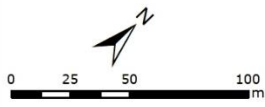
