	1. Discussion of Recommendation Regarding the Heritage Conservation District		
	Stephen Robinson, Senior Heritage Planner with the City of Guelph presented visuals and a brief description of the recommendation by staff and its consultants to include the Wellington Street Dam and the body of water that it creates in the Speed River as a cultural heritage attribute within the proposed boundary of the Brooklyn and College Hill Heritage Conservation District. Stephen advised that before Council makes a decision whether to keep or remove the Wellington Street Dam, an environmental assessment will need to be conducted to review all aspects of the dam, its function and its surroundings. David Cuming (MHBC Planning), a member of the consultant team that created the HCD Heritage Assessment Report for the City, was present at the meeting and took part in the discussion providing brief comments on the cultural heritage value of the dam and the water levels it creates in the Speed River. 2. 148-152 Macdonell Street (Tricar)

Krista Walkey, from Stantec Consulting, gave a presentation on the 148-152 Macdonell Street (Tricar) application and was available to respond to questions.

- Concerns with landscaping (not native species)
- The design be modified for street trees
- The health of the trees are of utmost importance for their longevity
- Concern of bird strikes to buildings

- The use of native tress where ever possible;
- The use of enhanced tree planning and/or City of Kitchener's "Soil Habitat Zones and Volume Requirements for Trees in Boulevards";
- Bird strike mitigation techniques be applied to floors 3 and 4 windows and balconies per FLAP guidelines."

Hugh Whitely spoke to the Committee and advised that OPA 48 is a complete rewrite. He also noted that OPA 48 has not come before RSAC for comment.

General discussion took place and it was noted that RSAC should be given an opportunity to provide comments on the Official Plan. It was requested that City staff speak to OPA 48 at a future meeting.
