ZONING BY-LAW INTRODUCTORY STATEMENT

This document is the City of Guelph Comprehensive Zoning By-law 1995 - 14864. The By-law replaces the City of Guelph Restricted Area (Zoning) By-law 1971 - 7666, as amended.

Purpose of a Zoning By-law

A Comprehensive Zoning By-law is a precise document used by the City to regulate the use of land. It states exactly what land uses are currently permitted in Guelph and provides other detailed information such as:

- where buildings or structures may be located;
- types of uses and dwellings permitted;
- standards for lot size, parking requirements, building height, and required yards.

Guelph's Zoning By-law is needed to help the City implement the objectives and policies of the Official Plan. The Zoning By-law acts as a legal tool under Ontario's Planning Act for managing the use of land and future development in the City.

Zoning By-laws also protect property owners from the development of conflicting land uses. Any use of land or the construction or use of any building or structure not specifically authorized by the By-law is prohibited.

Abbreviated Summary of Zoning By-law Sections

The complete text and zone maps of the Zoning By-law are presented in this document. The following is a brief summary of the contents of the Comprehensive Zoning By-law.

- <u>Section 1:</u> Explains the title given to the entire document.
- <u>Section 2:</u> Provides guidelines on the interpretation and administration of the Zoning By-law.
- <u>Section 3:</u> Defines many of the words and terms used in the By-law.
- <u>Section 4:</u> Describes and explains the general regulations which apply to more than one of the Zones in the Zoning By-law. The general regulations cover such matters as: accessory buildings or structures, parking, home occupations, outdoor storage, accessory apartments, etc.

Sections 5 to 16:	Set out the permitted uses and regulations for the specific land use Zones.
<u>Schedule "A":</u>	Presents Special Defined Area maps 1 to 75. These maps delineate the location of all Zones outlined in Sections 1 to 16 and Schedule "B".
<u>Schedule "B":</u>	Explains in detail the permitted uses and regulations of specific specialized Zones for the various land use Zones outlined in Sections 5 to 16.

How to Use the By-law

For each Zone, there is a list of permitted uses and a number of standards or regulations such as lot size, frontage, required yards, building height, etc.

The location of each of these Zones is shown on the Schedule "A" Special Defined Area Maps 1 to 75. The specific uses and regulations applicable to each Zone are found in the relevant section(s) of the By-law which bears the same Zone name(s).

In order to determine the provisions of the By-law that affect your property, it is suggested that you use the following technique:

- 1. Locate your property on the Index Map of Defined Area Maps within Schedule "A".
- 2. From the Index Map you will be able to identify the Schedule "A" Map (Maps 1 through 75) on which your property is located.
- 3. Turn to the appropriate map and identify the Zone that has been applied to your land (e.g., R.1B for Single Detached Dwellings or NC for Neighbourhood Shopping Centre, etc.).
- 4. Once you have identified the Zone, turn to the appropriate Zone Permitted Use and Regulation section of the By-law. For example, if your property is zoned R.1B, you would turn to Section 5.1 and Table 5.1.2 to determine the specific permitted uses and regulations affecting your property.
- 5. Please note that most of the general provisions contained under Section 4 also affect your property. Care should be taken to review these general regulations as well as the applicable definitions outlined in Section 3.
