Association of Municipalities of Ontario (AMO) Request for Support of North American Free Trade Agreement (NAFTA) Resolution

Councillor Downer will speak to this item.

Recommendation:

Whereas, the North American Free Trade Agreement (NAFTA) governs nearly every aspect of Canada and the United States economic relationship including manufacturing, agriculture, resources industries, and services;

Whereas, about 80% of all of Ontario's exports go to the United States and Ontario is the top trading partner of half of all American States;
Whereas, even minor changes to the established trade relationship between Canada and the United States could have significant consequences for workers, consumers, and governments on both sides of the border;

Whereas, Canada's and Ontario's economic future and the continued well-being of communities and their local economies depend on free and fair trading relationships based in current future trade agreements;

Therefore, be it resolved:

That Ontario municipal governments, represented by the Association of Municipalities of Ontario (AMO), stand together with the Federal and Ontario governments in their efforts to protect Canadian jobs and local economies;

That AMO will work with the Province of Ontario to support the interests of municipalities and communities affected by trade disputes and during ongoing trade agreement negotiations;

That AMO will work with the Federation of Canadian Municipalities to ensure that Canada understands the municipal impacts affected by trade disputes and during ongoing trade agreement negotiations; and be it further

That the City of Guelph supports AMO's resolution regarding the North American Free Trade Agreement negotiations.

SUBJECT: Guelph Police Service Board Capital Budget Request

Purpose: To provide staff comment on the Guelph Police Services (GPS) Board request to prepurchase 10 fleet vehicles in the amount of \$332,500 that are included in the 2019 capital budget request.

Background: In early May 2018, Ford Motor Company (Ford) announced that the Taurus sedan was being discontinued and announced a new model of the Police Inceptor effective 2019. The deadline for ordering the current models of both the sedan and utility, is September 30, 2018 but Ford has suggested that orders be placed earlier in order to guarantee inventory. Staff reviewed various alternative options including switching to an all SUV fleet or the Dodge Charger, however, all known options had higher capital and operating impacts. Additionally, it is not expected that equipment in the vehicles, which is currently reused, will fit into the new model of the SUV or the Charger. Through the replacement of the utility vehicles, staff will also be looking at greening the fleet by purchasing hybrid vehicles which will be available in 2019. These vehicles are expected to have significant fuel and maintenance savings and it has been indicated by Ford that the vehicle based equipment we currently own should fit in the new hybrid models. It should be noted that physical receipt of the vehicles will not occur until 2019.

Recommendation: Staff support the GPS Board recommendation to pre-purchase the 2019 fleet vehicles for a total amount of \$332,500 to be funded from the Police Services Capital Reserve Fund #158.

It is recommended that Council approve the following:

That the Guelph Police Services Board request to pre-purchase 10 fleet vehicles in the amount of \$332,500 to be funded from the Police Services Capital Reserve Fund #158 be approved.

The Guelph Police Service's 2019 Capital Budget Estimates were approved by the Guelph Police Services Board at the open meeting held on Thursday, July 19, 2018. The following motion was made and unanimously carried by the Guelph Police Services Board:

WHEREAS the Guelph Police Services Board is committed to the corporate goals from the 2016-2018 Strategic Business Plan and to its responsibility for the provision of adequate and effective policing for the City of Guelph; and

WHEREAS the Guelph Police Services Board has conducted a comprehensive review of the 2019-2028 Capital forecast prepared by the Chief and Guelph Police Service staff; and **BE IT RESOLVED** that the Guelph Police Services Board approves the Guelph Police Service 2019 Capital Budget in the amount of \$1,970,000; and

THAT the Guelph Police Services Board receives the Guelph Police Service Capital Forecast in the amount of \$1,673,000 in 2020, \$1,226,700 in 2021, \$1,316,200 in 2022, \$3,827,100 in 2023, \$1,622,400 in 2024, \$1,613,400 in 2025, \$1,544,600 in 2026, \$4,066,400 in 2027 and \$1,846,400 in 2028 for information and planning purposes; and THAT the Guelph Police Services Board approve the pre-purchase of 10 fleet vehicles in the amount of \$332,500 to be funded from the Police Services Capital Reserve Fund #158; THAT the request to pre-purchase 10 fleet vehicles in the amount of \$332,500 be referred to the July 23, 2018 Council Meeting for Council approval; and THAT the Board forward this information to the City of Guelph Council.
