**PS-2015.21 BUSINESS LICENCE BY-LAW REVIEW – FOOD
VEHICLE SCHEDULE AND TEMPORARY FOOD
SALES UPDATE**

Jakki Prince asked for clarity surrounding the different categories of food trucks identified in the proposed by-law. Additionally, Ms. Prince recommended to Council that gourmet food trucks be permitted in the downtown area in 2015 as well as in city parks.

Reuben Sologna, a food truck owner and member of the Ontario Food Truck Association, spoke in favour of the proposed by-law.

Bruno Rachiele encouraged Council to grandfather in current food truck/cart establishment as well as to loosen the rules surrounding who can serve food at city festivals.
