| <p>The tax deferral amount means the total tax increase related to an assessment increase over the previous year which is equal or greater than \$200 annually.</p> <ul style="list-style-type: none"> <li>The deferred taxes form a priority lien on the property and must be paid in full upon any registered change in title or sale of the property or change in eligibility.</li> <li>Must own and occupy the property as a principal residence and have owned the property for at least one year.</li> <li>Application for deferral must be made annually before the last day of December in the year for which the application applies.</li> <li>Must provide proof of eligibility.</li> </ul> |
